

COVID-19 Home School Agreement

This agreement has been set out by The Tapscott Learning Trust and adapted by Curwen Primary School in line with guidance from central government and the DfE to re-open our schools from 01 June 2020.

Our aim for producing this agreement is to ensure that children, parents and staff at our schools are committed to ensuring the safety and wellbeing, so far as is reasonably practicable of all users of the school during the COVID-19 pandemic.

We will endeavour to provide a safe environment for our pupils; however with the current restrictions of social distancing in place, we all need to collectively ensure that we are doing our utmost to control the spread of infection.

The school will, as far as is reasonably practicable:

- Try to ensure the safety and well-being of all users of our school buildings
- Try to arrange the building so that everyone can maintain their personal space
- Ensure we are cleaning and sanitising all areas of our school regularly throughout the day
- Try to ensure that all equipment used by children is cleaned and sanitised throughout the day
- Inform you immediately if we are concerned about your child feeling unwell
- Provide you with ongoing information in relation to your child's safety and wellbeing at school
- Provide you with information on any changes to our arrangements or routines in the school
- Follow government guidance and best practice in relation to your child at school
- Provide children with the best possible outcomes given the current situation

Families, as far as is reasonably practicable to:

- Stay safe and consider other members of the public
- Follow guidance given by your child's school on the arrangements for pupils
- Follow guidance given by your child's school pertaining to drop off/collection of your child/ren
- Maintain personal space whilst on or around the school premises
- Follow government guidance on staying safe outside the school perimeter
- Bring children to school regularly and provide reasons for any absences
- Adhere to the government guidance if there are any COVID-19 symptoms in your household, inform the school and apply for a test. Ensure your child does not return to school for **at least** 14 day
- Adhere to government guidance if your child is showing symptoms of COVID-19 (fever, cough, loss of taste/smell). Apply for a test **immediately** via www.nhs.uk/coronavirus or phone 119. Do not return to school until you have the results and inform school of the outcome
- Look out for information from the school and follow any guidance that is sent to you via the school app, website and Studybugs
- Speak to your child/ren about good hygiene practices such as hand washing and using tissues
- Drop off and pick up children at the allocated times and following the school's one-way system
- Inform the school if someone else is picking up your child, and ensure only 1 adult picks up/drops off
- Not enter the school building at any time and follow guidance on how to contact the school

My child will, as far as is reasonably practicable:

- Stay safe and be mindful of the safety of others
- Respect and listen to instructions given by the school or their class teacher
- Follow any new arrangements around the building
- Maintain personal space whilst on the school premises
- Maintain good hygiene practices at home and in school by washing their hands regularly
- Take responsibility for their actions that could impact others
- Be a good role model for others
- Tell an adult if they are not feeling well
